The President, Barbara Butterfield, called the meeting to order at 9:07 am. A quorum was present with 35 parcels present and 17 parcels voting by absentee ballot.

Introduction of Members and Guests: Those present introduced themselves.

CONSENT AGENDA

Motion to accept the Minutes of the previous Annual Meeting: Karen Austermiller moved and Abby Harbicht seconded a motion to accept the 2016 Annual Meeting Minutes. The motion passed unanimously.

REPORTS TO THE MEMBERSHIP:

Neil Cooperrider presented the Financials and Assets as of 31 October 2017 and noted that the funds in the Trail Fund account are from donations, not from annual dues.

Barbara Butterfield presented the results of the yearly audit which was completed by Susan Baxter and Jim Sheehan.

Jack Hansen presented the road report and thanked all the members of the road committee and community that have participated in the road improvement program. This year 2000 tons of material was placed on the roads in August and they were watered, graded and rolled. Additionally, drainage work was completed on the ditches and rip rap placed at appropriate spots. The committee plans to grade, water and roll the roads again this winter.

Karen Austermiller presented the Firewise presentation. She explained the work of the Firewise Committee, the meetings they had with the Prescott Area Wildland Interface Committee (PAWUIC), the large refuse containers made available this year, and

Ron Runger asked how the 911 system operates. George Price explained and that the calls go through the sheriff's office and are vectored to the appropriate agency. There is a paramedic on duty at the fire station 24/7.

Thanks to Dee & Jack Hansen for bringing the refreshments, and to Rhonda and Mike Tellam for the cookies. Everyone indicated a desire to head for the refreshment table.

Motion to Adjourn: Paula Cooperrider moved to adjourn and Jack Hansen seconded the motion. The motion passed unanimously and the meeting was adjourned at 9:56 am.
